**AMENDMENT NUMBER 1
(COUNTY - KERN HEALTH SYSTEMS)**

(COORDINATION OF SERVICES MHP SMHS AND DMC-ODS)

This Amendment Number one is entered into on NOV 12 2024, by and between Kern Health Systems ("MCP"), and the County of Kern ("County") ("MHP/DMC-ODS"), a political subdivision of the State of California, as represented by its Kern Behavioral Health and Recovery Services Department ("KernBHRS"), located at 2001 28th Street, Bakersfield, California 93301.

WITNESSETH:

WHEREAS:

- A. On May 21, 2024, KernBHRS and MCP entered into Agreement No. 215-2024 for the term of five (5) years entitled "Coordination of Services MHP SMHS and DMC-ODS" (hereinafter "Agreement") providing coordination and access to Specialty Mental Health Services (SMHS) and Drug Medi-Cal Organized Delivery System (DMC-ODS) for members of the MCP in a coordinated manner from MCP and MHP and DMC-ODS.
- B. KernBHRS and MCP wish to amend Agreement 215-2024 to modify Exhibit A, MCP-MHP Liaisons and Exhibit B, MHP and DMC-ODS Liaisons, to update and include additional contact information.

NOW, THEREFORE, the parties mutually agree hereto as follows:

- 1. Section 4.b.Oversight Responsibility shall be deleted in its entirety and superseded by the following:
 - b. **Oversight Responsibility.** The Director of Behavioral Health, the designated MCP Responsible Person listed in Exhibit A of this MOU, is responsible for overseeing MCP's compliance with this MOU. The MCP Responsible Person must:

- 3. "EXHIBIT "B," MCP and DMC-ODS Liaisons, shall be deleted in its entirety and superseded by EXHIBIT "B" TO AMENDMENT NUMBER ONE, which is attached hereto and made a part hereof. All further references to Exhibit "B" in the body of the Agreement, or any exhibits thereto, shall be deemed to read EXHIBIT "B" TO

AMENDMENT NUMBER ONE.

4. To the extent that they do not conflict with the terms of this "AMENDMENT NUMBER ONE," all other sections and provisions of the Agreement shall remain in full force and effect. In the event there is any inconsistency between the terms hereof and the Agreement, this "AMENDMENT NUMBER ONE" shall control.


